NEW BUSINESS

- Commissioner Ernie Hovell reported that the food permit for the Auditorium kitchen in the Community Centre has been renewed and posted
- There were discussion around the display cabinet and water filling station
- It was mentioned that Lewis Benedict is the Village's representative for Volunteer of the Year and was nominated by five different organizations in the Village
- Commissioner Doug Gates mentioned that some of the shingles on the Community Centre roof by the doors seem to be curling Joe committed to looking into the condition of the roof.
- Covid 19 –After discussions regarding Covid-19 pandemic it was decided that the Villages park will not be open to the public and that Joe will place a type of barricade at both entrances. Also, the office and Community Centre will be closed to the public with limited access to the office by appointment only.
- After discussions it was agreed by the Commission that there should be a response to the Minister regarding their recent amendment to the Municipality's Land Use By-Law specific to enforcement to stock piling of manure when limits are exceeded; asking who that contact would be for enforcement; expressing the concern that our current well field protection document has no enforcement and if there is money which the Village can utilize to purchase land in the well field.
