- It was mentioned that the design is part of the Villages financial consideration for the 2021/2021 fiscal year and that the Project work will be in the 2022/2023 fiscal year.

• Joe mentioned that he would like to clear more brush around the property lines to better define boundaries and possibly do further clearing for ease of maintenance. Commission agreed that it was a good idea to clear the property line of brush and asked that Joe investigate the cost and present a proposal of the scope of work to the Commission for consideration.

- 1) Determining the depth of the sewer line where they intend to connect and elevations recorded so the sewer line can be designed.
- 2) Detailed survey plan showing Infrastructure and easements.
 - Fire inspection at Community Center complete.
 - Hot water tank at Community Center needs to be replaced
 - Installed manhole at the end of sewer line on Belcher
 - Water main breaks at the school.
 - Sewer back up at Cornwallis farms
 - Sewer back up at 1108 Belcher
 - Couple complaints about water quality and pressure.
 - Recreation fields and maintenance.
 - Responded to 4 alarms
 - Need to look at repairs to the ball field dugout and outdoor recreation building – Joe to follow up with Karen regarding available funds for repairs.
 - Nitrates 5.2 outlet and 5.6 inlet

- A motion to accept the Village General Operating and Water Utility financial statements for June 2021, as submitted was moved and seconded. MOTION CARRIED
- Motion to amend the June 15, 2021 motion increasing the Village's contribution to the FRIIP Funding application by \$3,120.00 for contingency expenses was moved and seconded. MOTION CARRIED
- Commissioner Hovell mentioned that he heard that there will be additional
 infrastructure funding from the federal government. After discussions the
 Commission asked Karen to contact the Municipality to see if there have been
 any discussions regarding additional funding.
