#### **BUSINESS ARISING FROM MINUTES:**

- (a) Historic Terry's Creek Planter signage Commissioner Kim Cogswell spoke with Margretta Kristiansen, who explained that the Kings Hants Heritage Connection has been approaching individual communities with the proposal to erect signage which would display the historic Planter name of the community. (g) Kings Partnershop Steering Committee - Chairperson Lewis Benedict will attend a meeting with other Kings County Village representatives on September 24th to determine how the Villages would like to be represented when the Committee meets in October.

#### **REPORTS:**

Public Information Meeting: Emma Van Rooyen emailed that there was not a large turn out at the public information meeting for development agreement being requested to convert the Barracks on Starr's Point road into a tourist accommodation. Most everything that was said in regards to the project was positive.

Climate change action plan - Staff reported that they met with David Poole who explained that there is a directive from the Province for Municipalities to complete a

Municipal Climate Change Action Plan by December 31,2013 on how climate change will effect local infrastructure. In order to provide accurate information they would like the Village to review the current data they have and provide any missing information. He also stated that they are looking as directing some of the gas tax moneys towards dykes/flood protection. The Superintendent of Public Works was to review the map for any omissions on our infrastructure and report back to David Poole.

- Things are getting busy
- Multi-Purpose room has been cleaned walls washed and dents or holes have been filled.

## Fire Department: Philip Porter reported

- Slow as far as alarms go
- One alarm was for the wrong location and was not a Port Williams alarm
- Have a wedding reception this Saturday that they will be catering
- In November they have booked Jimmy the Janitor for a fundraiser

### Recreation Committee: Brian reported.

- Steve Wolmouth from Launchers was invited to go to Ottawa for a special training/coaching opportunity which the committee committed to assist him with some of the cost should he not be able to raise all the funds required
- Committee is looking into a fitness program for seniors over the winter

#### Lions Club: Brian reported.

- The Lions have helped a local resident financially with much needed dental work
- Five local clubs are coming together for a meeting this week
- Doing the Adopt a Highway fall clean-up in October

## Water/Sewer/Public Works/Transportation Report: Joe Keddy reported

- Working with the new infrastructure turned over to the Village in the Lawrence Park development - will require regular flushing until more homes are using the water lines.
- Will be adding calibration of monitoring equipment as an additional expense to the budget.
- Have been in contact with the Department of Transportation regarding road conditions and bushes. Reported to the Fire Department that four fire hydrants are not working.
- Replaced two sewage pumps which were not working on Kars Street
- Repaired the water service break on Centennial Drive

- Will be working with commercial customer and our engineer to install new meter and appropriate back flow prevention
  - Working with our engineers on water withdrawal study
